## Invitation to Bid for **CONSTRUCTION OF ENGINEERING BUILDING (COMPLETION)**

1. The **SAMAR STATE UNIVERSITY**, through the **GAA-Capital Outlay FY 2015** intends to apply the sum of **Six Million Pesos (Php6,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Engineering Building (Completion)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **SAMAR STATE UNIVERSITY** now invites bids for:
  - RESTORATION WORKS AT LOWER GROUND FLOOR
  - CONCRETE WORKS AND STEEL REINFORCEMENTS
  - STRUCTURAL TRUSS, ROOFING AND ACCESSORIES
  - STEEL WORKS
  - MASONRY WORKS
  - MOVABLE PARTITIONS
  - ELECTRICAL/AUXILIARY WORKS
  - PLUMBING & SANITARY
  - PAINTING WORKS
  - TILE WORKS
  - DOORS AND WINDOWS
  - CEILING WORKS
  - MINI STAGE
  - STUDENT KIOSK AND COVERED MOTORCYCLE PARKING AREA
  - OTHER EQUIPMENT AND SUPPLY
  - TESTING REQUIREMENTS
  - PROJECT TURNOVER AND DEMOBILIZE

Completion of the Works is required **One Hundred Twenty (120) Calendar Days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations

(IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **Samar State University** and inspect the Bidding Documents at the address given below from **Mondays through Fridays, 8:00 – 5:00 in the afternoon.**

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (PhP10,000.00).**

*It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.*

6. The **Samar State University** will hold a Pre-Bid Conference on **November 4, 2015** at **Mabuhay Conference Hall, Second Floor New Administration Building, Samar State University, Catbalogan City, Samar**, which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before **November 16, 2015, 1:30 in the afternoon** at **Mabuhay Conference Hall, Second Floor New Administration Building, Samar State University, Catbalogan City, Samar.**


8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18, as follows:

**at Mabuhay Conference Hall, Second Floor New Administration**  
**Building, Samar State University, Catbalogan City, Samar.** Bids will be  
opened in the presence of the bidders' representatives who choose to attend at the  
address below. Late bids shall not be accepted.

9. The **Samar State University** reserves the right to accept or reject any bid, to annul  
the bidding process, and to reject all bids at any time prior to contract award, without  
thereby incurring any liability to the affected bidder or bidders.
